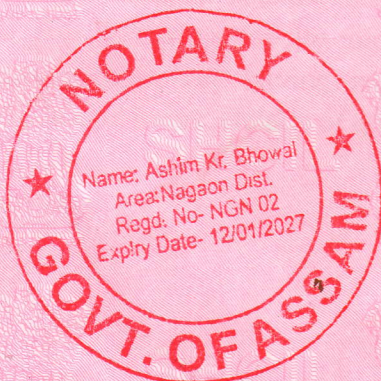


## AFFIDAVIT

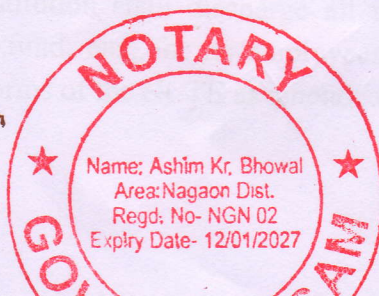

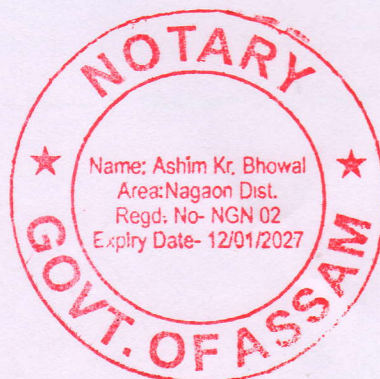
